DISCLOSURE OF TIMELINE INFORMATION

Madison College is currently at peak processing time. Applying during peak processing can delay program application processing and the receipt of financial aid and/or veterans benefits funds. This may impact your ability to have a successful term start. Please note the following information regarding applying to Madison College at this time:

- It may take up to 6 weeks to process Admissions applications. Required credentials should be submitted as soon as possible as applications are not considered until all required materials are received.
- If receiving financial aid, it can take 2-6 weeks for processing depending on the timing of submission and if you are selected for additional verification. Verification and appeals (if applicable) must be resolved and you must be admitted into a financial aid eligible program before you can be awarded financial aid funding. Book charge and emergency assistance funding may not be available.
- If applicable, your Pell Grant award is based on your class schedule as of the Pell Recalculation Date (PRD). As of the PRD, you must be removed from any class wait-lists and officially enrolled, regardless of the class start date. The PRD for Fall 2026: Friday, September 11, 2026 at 4:30 pm.
- Tuition for Fall 2026 is due September 30, 2026 regardless of financial aid and/or veterans benefits status. Any unpaid tuition after the tuition due date is subject to collections.
- If classes are dropped, they must be dropped at least one day before the class starts to qualify for a 100% refund. Registering for a class after the class start date does not adjust the refund period and at least a portion of the class fee(s) will be owed. - If you plan on receiving veterans benefits, processing times can vary. If you have questions regarding veterans benefits, please contact Veterans Services at veterans@madisoncollege.edu or call (608) 246-6038.
- Should you start a class after its official start date, you will be expected to complete any missed work/assignments. You are advised to connect with the course instructor for details.
